

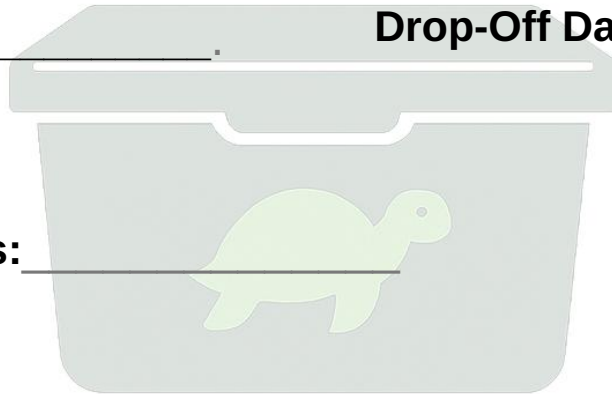

## 1. Agreement to Terms

### **4. Photo Documentation**

Renter consents to photos being taken at pickup and drop-off to document bin condition and inventory.

Photos are stored securely and used only for internal documentation.

### **5. Property Access & Disclaimer**

All bin exchanges occur outside the residence at a designated sidewalk-accessible location.

Renter agrees not to enter the property.

The property owner is not affiliated with Tidy Turtle Eco Bins and bears no liability for rental activity.

## **6. Credit Card Authorization**

A valid credit card must be provided and kept on file until the rental is complete.

If payment is not received within 72 hours of final invoice, the card may be charged for the full balance, including any damage or missing bin fees.

Renter authorizes Tidy Turtle Eco Bins to charge the card on file for any unpaid fees, damage charges, or missing bins.

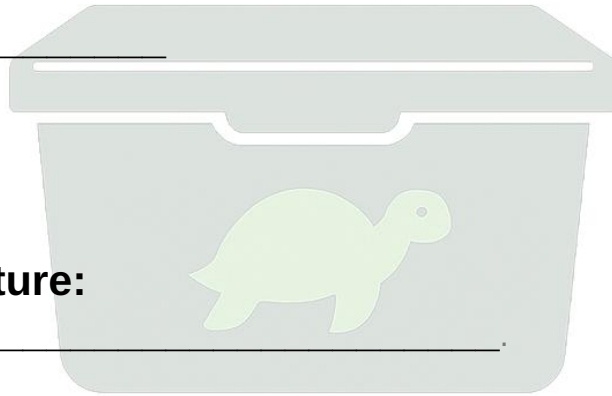
